

2022/23 BIQ Offerings and Pricing

Evidence IQ currently has several products for our law enforcement agencies. Those include our Ballistics IQ, Quality Assurance Team Reviews, Rapid- Ballistics, Investigative Lead Reports, and Confirmatory Services.

Ballistics IQ – \$14,999/year:

- One (1) BIQ capture station with hard-sided travel case
- Unlimited Crime Scene Analysis (CSA) Triage Reports
- Unlimited User accounts
- Unlimited capture tool software downloads
 - only need to be downloaded on computer(s) that will be attached to the BIQ capture station
- 10 (ten) Rapid-Ballistics case submissions
 - See details below
- On-line user training / refresher program
- One-year warranty on microscope and life of the contract on capture station
- Single year and multi-year contracts available
- \$14,999/year/box

Rapid-Ballistics - \$250/CSA submission:

- Users will submit CSA report they want reviewed
- Firearm examiners review the submitted CSA report
 - All services listed under Quality Assurance Team Reviews below
 - Possibly identify Make of firearm(s) involved
 - Search BIQ gallery for any Potential Links between the fired cartridge cases (FCC) on the CSA report, and to other FCCs in BIQ gallery
 - Provide the user a report of their findings (Potential Link / No Potential Link Found)
 - Average turnaround time is three hours for routine submission, one hour for urgent requests
- \$250 per CSA submission and sold in bundles of ten, customizable to agencies needs

Quality Assurance Team Reviews – No cost at this time:

- Users can submit CSA reports for review, at no cost to the agency, to the Quality Assurance Team. The team will only review the CSA report for accuracy and **NOT** search for Potential Links nor provide make of firearm(s)
- Users will notate in the comments section “Please provide a QA review”
- CSA’s that meet the following criteria can be submitted:

- CSA report with 3 or more Undetermined FCCs
- CSA report has a disproportionate number of firearms identified compared to the number of FCCs, such as 15 FCCs and 7 identified firearms, especially involving .223/5.56 caliber FCCs

Investigative Lead Reporting Software access - \$5,000/year upgrade

- For those agencies that have their own Firearms Examiners and/or correlation-trained NIBIN technicians, these agencies have the option to upgrade to the Investigative Lead Report software:
 - Access to the virtual comparison microscope software to assist in examining FCCs
 - Able to conduct searches within their gallery for potential links
 - Provide members of their agency with an Investigative Lead Report (not reviewed by the BIQ team) identifying potential associations between FCCs
 - Agencies with firearms examiners and/or correlation-trained NIBIN technicians can currently do this already with their microscopes in the forensics lab, but this software allows them to conduct the searches and prepare the reports all from our software
- Single upgrade price per agency, not per examiner

Confirmatory Services - \$750 per submission:

- Firearm Examines will provide confirmation services on items of evidence that have been identified as connected either through BIQ Potential Link Report or a NIBIN lead.
- Agencies request service by sending an email to Confirm@evidenceiq.com with agency point of contact information
- Agencies will send the two pieces of evidence to a BIQ examiner
- BIQ Firearm Examiner will
 - Review the physical evidence under a comparison microscope
 - Prepare a court-ready report that is peer reviewed by another examiner
 - FedEx evidence back to submitting agency
 - Be available to testify in court proceedings
 - Actual court testimony is not included, Agency/prosecution will contract directly with examiner who provided the confirmation
- Can be purchased in bundles of ten submissions for \$7,500
